#### **COURSE DESCRIPTION:**

Leaders of peacebuilding, justice building, and social change programs require more sophisticated knowledge of research methods than they did even five years ago. We have always focused on DOING research projects with students, but they now require greater ability to design and justify research projects as part of their work. This course opts for qualitative methods, because those are used more often in the field than quantitative methods. In addition, this course will introduce you to quantitative and mixed methods research so that you may be able to better read, interpret, and/or design appropriate studies depending on their aim. This course is required for all MA students.

#### **COURSE GOALS AND OBJECTIVES:**

Qualitative inquiry – rooted firmly in the foundations of the social sciences, critical theory, and social justice – provides us with the tools to explore, unearth, understand, and make explicit the world within which we live: ourselves, others, social issues, interactions, and phenomenon. This course is designed to inspire, teach and engage you in conducting qualitative research. Through this course, you will:

- √ Contrast paradigms of inquiry and their philosophical tenets
- ✓ Differentiate qualitative inquiry from quantitative analysis;
- ✓ Explore, identify, and evaluate qualitative research designs;
- ✓ Learn, distinguish, and practice methods (e.g., intensive interviewing, focus groups, observations, document analysis, etc.) commonly employed in qualitative inquiry;
- ✓ Learn and practice the steps involved in planning, designing, implementing, coding, and analyzing qualitative data;
- ✓ Propose, design, and implement a research project that includes a masters-level literature review and trustworthiness (validity and reliability) standards.

#### REQUIRED TEXTS AND OTHER RESOURCES:

Please note: Journal articles and/or other scanned readings will be assigned for each class period and available on Moodle.

#### **REQUIRED ASSIGNMENTS:**

These are brief descriptions of required graded assignments for the course. More details for each assignment can be found on the "Guidance Notes" that will be provided in class.

Critical article reflections (40 points): The transition into graduate school involves a shift from knowledge consumption to knowledge production. This requires a change in orientation toward your reading, moving from a passive "flow" state to an active and critical focus. To develop this reading orientation and enhance class discussion, you will submit a .33 - .5 page reflection per article due that week (single-spaced and typed). Note that these are only over the articles and not the chapters from the Merriam & Tisdell book. You will bring a hard copy of these reflections to class the week the readings are due. These are not simply reviews of the articles, but rather critical reflections showing me you have thoughtfully digested the material (i.e., they will show me that you have read the article without providing me a summary/review of the article). You should be making connections to other readings and the chapter due that week if applicable. There are 11 of these possible and you can choose any 8 to turn in. They are worth 5 points each.

**Critical chapter notes (30 points):** Every class a chapter from the Merriam & Tisdell book is due, you will turn in a one-page typed (or handwritten if you have  $\sim 12$  point font handwriting) copy of the notes you took over the chapter (notice that I want you to photocopy your notes so that you can keep the original). Notice that I recommend at least one page but you can turn in up to two pages. I encourage you to pull out key ideas/points/summaries to submit to me. You should especially include comments challenging the text in addition to any connections to other chapters we have read as that will show me that you are thoughtfully considering the material. In other words, show me you are thinking! As the class progresses and you develop your research topic of interest, you should increasingly make connections between the readings and your own project. There are 10 chapters and they are worth 3 points each.

#### Activities (~50 points)

You will complete various activities designed to prepare you for your final project and develop competency in writing, research, and analysis. Among these various activities will include a literature review that will serve as part of your final project.

#### Final project (100 points)

The final project for the course will be a qualitative project of  $\sim 15$  pages (this does not include the abstract, references, and appendices). The project shall clearly address a relevant gap in the

©2019 Aaron PeeksMease, PhD PAX 535 Fall 2019 literature of interest or need for your study, include a compelling research question, appropriate methodology, sample, and trustworthiness (validity and reliability) standards. Research projects must take you out to the world to collect a variety of forms of data and to make sense of that data. You are required to conduct three 45 minute interviews (one must be fully transcribed), two hours of observation, and acquire at least one type of archival data.

The final research project report should contain the following elements: • Abstract • Purpose and research questions • Subjectivity statement • Literature review • Description of participants and context • Explanation of data collection process • Explanation of data analysis • Findings and discussion • Appendix to include transcribed interview, observation notes, and archival materials

# Presentation of project (10 Points)

As it is important to share your work with your colleagues and the larger scholarly and practitioner communities, you will present your research project at the end of the semester. More details will be provided later in the semester.

**Additional requirements:** All students must have successfully completed IRB training for Human Subjects Research. Students who have completed training already do not need to complete it again. Failure to complete human subjects training will result in a 10 point penalty on your final project grade.

#### **LATE SUBMISSION POLICY:**

You will be penalized for turning in anything late based on what I feel is appropriate and you can never receive more points than the lowest grade received by someone who turned it in on time.

#### **Writing Guidelines:**

Writing will be a factor in evaluation: EMU has adopted a set of writing guidelines for graduate programs that include six sets of criteria: content, structure, rhetoric & style, information literacy, source integrity, and conventions (see page 3). It is expected that graduates will be able to write at least a "good" level with 60% writing at an "excellent" level. For the course papers, please follow the APA style described in CJP's GUIDELINES for GRADUATE PAPERS (see CJP Student Resources Moodle page or request a copy from the Academic Program Coordinator), unless directed otherwise by the instructor.

### **Academic Integrity Policy (AIP):**

EMU faculty and staff care about the integrity of their own work and the work of their students. They create assignments that promote interpretative thinking and work intentionally with students during the learning process. Honesty, trust, fairness, respect, and responsibility are characteristics of a community that is active in loving mercy and doing justice. EMU defines plagiarism as occurring when a person presents as one's own someone else's language, ideas, or other original (not common-knowledge) material without acknowledging its source (Adapted from the Council of Writing Program Administrators). This course will apply <a href="EMU's AIP">EMU's AIP</a> to any events of academic dishonesty. If you have doubts about what is appropriate, <a href="Indiana University's Plagiarism Tutorials and Tests">Indiana University's Plagiarism Tutorials and Tests</a> may be a useful resource.

#### **Turnitin:**

Students are accountable for the integrity of the work they submit. Thus, you should be familiar with EMU's Academic Integrity Policy (see above) in order to meet the academic expectations concerning appropriate documentation of sources. In addition, EMU is using <u>Turnitin</u>, a learning tool and plagiarism prevention system. For CJP classes, you may be asked to submit your papers to Turnitin from Moodle.

#### Moodle:

Moodle is the online learning platform that EMU has chosen to provide to faculty, administrators and students. Students will have access to course information within Moodle for any class they are registered for in a given term. The amount of time a student has access to information before and after the class is somewhat dependent on the access given to students by the individual faculty member. However, please note that courses are not in Moodle permanently – after two years the class will no longer be accessible. Please be sure to download resources from Moodle that you wish to have ongoing access to.

#### Technology Requirements and Communication (if joining a class by zoom):

Communication will largely be accomplished via the Moodle platform utilized by EMU and your EMU email. Check both frequently during the semester. In addition, during class synchronous sessions, it will be expected that you will use a noise-reducing headset to minimize background noise and disruption. Remember to keep your headsets UNMUTED during the sessions and avoid moving, brushing, touching or fumbling with them as it creates unwanted noise in the class space.

#### Institutional Review Board (IRB):

All research conducted by or on EMU faculty, staff or students must be reviewed by the Institutional Review Board to assure participant safety.

#### **Grading Scale & Feedback:**

In most courses grades will be based on an accumulation of numerical points that will be converted to a letter grade at the end of the course (several CJP courses are graded pass/fail). Assignments will receive a score expressed as a fraction, with the points received over the total points possible (e.g. 18/20). The following is the basic scale used for evaluation. Points may be subtracted for missed deadlines.

> 95-100 = A outstanding 90-94 = A- excellent 85-89 = B + very good76-79 = B- satisfactory 80-84 = B good73-75 = C + passing70-72 = C unsatisfactory

Below 70 = F failing

Graduate students are expected to earn A's & B's. A GPA of 3.0 for MA students and 2.75 for GC students is the minimum requirement for graduation.

Regarding feedback on papers/projects: Students can expect to receive papers/assignments back in a class with faculty feedback before the next paper/assignment is due. This commitment from faculty assumes that the student has turned the paper in on the agreed upon due date.

#### Library

The Hartzler Library offers research support (via e-mail, chat, phone, or SSC campus) and the library home page offers subject guides to help start your research.

#### Office of Academic Access:

If you have a physical, psychological, medical or learning disability that may impact your work in this course, it is your responsibility to contact the Office of Academic Access in the Academic Success Center on the third floor of the Hartzler Library. They will work with you to establish eligibility and to coordinate reasonable accommodations. All information and documentation is treated confidentially.

#### **Class Attendance:**

Students are expected to attend all class meetings. If unusual or emergency circumstances prevent class attendance, the student should notify the professor in advance if possible. Multiple absences from class will result in lower grades. The student is responsible for the material presented in classes missed (from EMU Graduate Catalog). Students should be aware of the importance of regular class attendance, particularly in the case of CJP classes that only meet once a week or over several weekends. Being absent for more than one class leads to a student missing a large portion of the class content. In addition to consistent class attendance, students should make every effort to arrive to class on time out of respect for the learning process, fellow students and faculty.

#### **Course Extensions and Outstanding Grades:**

For fall and spring semesters, all coursework is due by the end of the semester. If a student will not be able to complete a course on time, the student must submit a request one week before the end of the semester for an extension (up to 6 months), by emailing the instructor, academic advisor and the Academic Program Coordinator. If the request is granted the student will receive an "I (incomplete) for the course which will later be replaced by a final grade when the work has been turned in on the agreed upon date. If the request for an extension is denied, the student will receive a grade for the work that has been completed up until the time the course was expected to have been completed. If no work has been submitted, the final grade will be an F (or W under unusual circumstances and with permission of

the Program Director). Extensions will be given only for legitimate and unusual situations. Extensions are contracted by the student with the program for up to a maximum of 6 months after the deadline for the course work. PLEASE NOTE: Grades for coursework submitted late may be reduced at the instructor's discretion and in line with their course policy on turning in coursework after the due date. If the extension deadline is not met, the instructor will submit the final grade based on what has been received to date.

# **Criteria for Evaluating Arts-Based Peacebuilding Projects**

#### Background notes:

- Arts approaches can be used in several different stages of a project:
  - 1. To gain or create knowledge. (For example, research "subjects" or participants might be engaged in an arts-based project as a way of soliciting information or encouraging insight.)
  - 2. To add complexity or nuance to created knowledge. (For example, an arts practice may serve as one method in a multi-method research project, creating an integrated, reflective methodology for the project. Alternatively, an arts practice could be used to analyze and/or interpret data collected by conventional methods.)
  - 3. To test knowledge. (For example, researchers might verify their interpretation of findings from a more traditional research process by creating a play or exhibit and testing it for resonance with their subjects.)
  - 4. To share findings. (For example, a play or exhibit might be created to (re)-present data collected or analyzed via conventional methods in order to impart the particular kinds of meaning the researcher considers important, and as a way to reach and engage a broader audience.)
  - 5. As a form of intervention. (For example, a project might be designed to raise awareness of an issue or conflict, to promote dialogue on a contested issue, or to advocate for a cause.)
- Arts-based products often do not specify methodologies used. Thus it may be important for a project to be accompanied by a short paper discussing analysis, theory of change, audience, goals, and methods used.
- Patricia Leavy, in "Method Meets Art: Arts-based Research Practice" (New York: Guilford Press) 2009, argues that "[t]raditional conceptions of validity and reliability, which developed out of positivism, are inappropriate for evaluating artistic inquiry." (p. 15). She suggests that authenticity, trustworthiness, and validity can be assessed through attention to such elements as aesthetics, resonance, and vigor.
