# **COURSE DESCRIPTION:**

This course provides a critical examination of the values, principles, and practices of restorative justice. It provides a unique opportunity to explore the philosophy of restorative justice from various perspectives, and as it is applied in various contexts. Our primary starting point is the U.S. criminal legal system and the problems posed by its dominant responses to harm and violence. We examine how restorative justice presents a contrasting philosophy of justice that addresses the needs of multiple stakeholders, draws from faith-based and indigenous approaches, and challenges interpersonal and structural forms of harm. We also explore intersections and applications of restorative justice with multiple fields and movements including racial justice, trauma healing, education, youth development, and transitional justice.

# COURSE GOALS AND OBJECTIVES:

This course will equip participants to:

- 1. Compare and contrast multiple approaches to justice, their origins, terminology, underlying assumptions, as well as their personal and social impacts.
- 2. Explain concepts, principles, and applications of restorative justice (RJ) to various audiences and engage with any resulting constructive criticism.
- 3. Analyze critical issues in the RJ field and present them to peers.
- 4. Examine RJ relationship to social justice movements, as well as concepts of power, privilege, and intersectionality.
- 5. Apply a restorative justice lens to the classroom experience, one's personal life, and other relevant contexts.

A note on restorative justice and the classroom experience. Required assignments, grading, and rules of conduct outlined in this syllabus are typical of educational settings, aimed at promoting learning, safety, and academic accountability. They are also in tension with restorative justice values of shared power and choice. This note is to acknowledge this tension and prompt ourselves to begin applying a restorative lens to our own classroom community.

# **COURSE COMPONENTS:**

This course is open to auditors as a form of professional education or training without academic credit. The different expectations of those taking the course for credit or auditing are indicated below.

• Class Participation (30 points) – expected of all participants

This course relies heavily on everyone's active and thoughtful participation in activities and discussions that draw on academic sources, as well as personal experiences and perspectives. The course brings together individuals who may come at sensitive issues from different life experiences and backgrounds. As such, we will be working to build trust and familiarity with each other. Within this container, be prepared to critically challenge assumptions, bring personal experiences to the learning process, and lean into discomfort with an open, respectful heart. Each session builds on understandings gained from prior sessions and that week's readings. Engaged listening, authentic self-expression, genuine inquiry, self-reflection, integrating theory and practice, building relationships, and creative and critical thinking are critical to getting the most out of this course and will be reflected by your participation grade. As a metric and incentive for punctual and consistent attendance, students will also be deducted 3 points for every class they miss in whole or in part (or every day that an assignment is late), unless resulting from circumstances beyond their control, such as illness, accident, religious observance, or university-sponsored athletic or other off-campus activities. Please inform me ahead of time if you anticipate an absence or late assignment.

- Teach Forward and Reflection (30 points) expected of all participants
   Teaching is a powerful form of learning. This assignment is an open invitation to educate others
   about restorative justice with a target audience and approach of your own choosing. Consider
   making a presentation to a community group, writing a letter to the editor for your local paper, or
   creating a video for social media. These examples are by no means exhaustive of the possibilities,
   so long as you spend at least four cumulative hours on the activity and preparation. Once
   completed, prepare a 3-page written or 10 minute orally recorded reflection of the experience that
   describes what you did, how it felt, what you learned, and what confusions, critique, or questions
   may have emerged. You may work in groups, but please still submit individual reflections. Due
   Friday, November 19, 2021.
- *Critical Issues Paper* (30 points) only expected of credit-bearing students What is a burning question that this class has brought to mind? What do you see as a critical issue or challenge in the RJ field or relevant to RJ philosophy? This paper gives you an opportunity to delve deeper into it by discussing existing perspectives, developing an original analysis, and delivering specific recommendations and/or a vision for change. Examples of critical issues or questions are: Is restorative justice appropriate to address gender-based violence? What is the relationship between movements for restorative justice and racial justice? Is restorative justice relevant for countries with little to no rule of law? Papers should be between 3000 to 6000 words in length and include your critical issue; a clear thesis statement and analysis of your position; a brief review of varying perspectives on the issue that references scholarship, grey literature, and other credible sources; as well as concluding recommendations or visions for moving forward. If you would like to submit an arts or media-based projects as an alternative format, please submit a proposal describing audience, goals, methodology, and project format (including details such as project length) for review at least three weeks before the due date to make sure it meets the learning goals of the assignment. **Due Friday, December 3, 2021.**

*Final Presentation* (10 points) – only expected of credit-bearing students Present your critical issues paper to the class in a way that brings it to life. In addition to talking, consider using guided activities or audiovisual materials such as a slide show or video. Keep presentations under 10 minutes to ensure there is time for all presentations, followed by Q&A and an instructor-facilitated discussion. **To be held Wednesdays, December 8 and 15, 2021.** 

# Please submit all written assignments through Moodle in the designated submission areas unless otherwise noted.

I appreciate creativity, evidence of engagement with the reading and class sessions, integration of your personal and professional experiences, as well as topics that are of great interest and value to you. Aim to express yourself using clear and concise communication. Quality is more significant than quantity.

These are brief descriptions of required graded assignments for the course. More details for each assignment can be found on the "Guidance Notes" that will be provided in class and on Moodle. Students taking the course for 2 credits will work with instructors to adjust the above requirements.

## Writing Guidelines:

*Writing* will be a factor in evaluation: EMU has adopted a set of <u>writing guidelines</u> for graduate programs that include six sets of criteria: content, structure, rhetoric & style, information literacy, source integrity, and conventions (see page 3). It is expected that graduates will be able to write at least a "good" level with 60% writing at an "excellent" level. For the course papers, please follow the APA style described in CJP's *GUIDELINES for GRADUATE PAPERS* (see CJP Student Resources Moodle page or request a copy from the Academic Program Coordinator), unless directed otherwise by the instructor. Criteria for Evaluating Arts-Based Peacebuilding Projects can be found at the end of this document.

## Academic Accountability & Integrity:

EMU faculty and staff care about the integrity of their own work and the work of their students. They create assignments that promote interpretative thinking and work intentionally with students during the learning process. Honesty, trust, fairness, respect, and responsibility are characteristics of a community that is active in loving mercy and doing justice. EMU defines plagiarism as occurring when a person presents as one's own someone else's language, ideas, or other original (not common-knowledge) material without acknowledging its source (Adapted from the Council of Writing Program Administrators). This course will apply <u>EMU's Academic Accountability Policy</u> to any events of academic dishonesty. If you have doubts about what is appropriate, <u>Indiana University's Plagiarism Tutorials and Tests</u> may be a useful resource.

#### Turnitin:

Students are accountable for the integrity of the work they submit. Thus, you should be familiar with EMU's Academic Integrity Policy (see above) in order to meet the academic expectations concerning appropriate documentation of sources. In addition, EMU is using <u>Turnitin</u>, a learning tool and plagiarism prevention system. For CJP classes, you may be asked to submit your papers to Turnitin from Moodle.

#### Moodle:

<u>Moodle</u> is the online learning platform that EMU has chosen to provide to faculty, administrators and students. Students will have access to course information within Moodle for any class they are registered for in a given term. The amount of time a student has access to information before and after the class is somewhat dependent on the access given to students by the individual faculty member. However, please note that courses are not in Moodle permanently – after three years the class will no longer be accessible. <u>Please be sure to download resources from Moodle that you wish to have ongoing access to.</u>

# Institutional Review Board (IRB):

All research conducted by or on EMU faculty, staff or students must be reviewed by the <u>Institutional</u> <u>Review Board</u> to assure participant safety.

#### Grading Scale & Feedback:

In most courses *grades* will be based on an accumulation of numerical points that will be converted to a letter grade at the end of the course (several CJP courses are graded pass/fail). Assignments will receive a score expressed as a fraction, with the points received over the total points possible (e.g. 18/20). The following is the basic scale used for evaluation. *Points may be subtracted for missed deadlines*.

*Regarding feedback on papers/projects:* Students can expect to receive papers/assignments back in a class with faculty feedback before the next paper/assignment is due. This commitment from faculty assumes that the student has turned the paper in on the agreed upon due date.

#### Library

#### Office of Academic Access:

*If* you have a physical, psychological, medical or learning disability that may impact your work in this course, it is your responsibility to contact the <u>Office of Academic Access</u>. #### Class Attendance (for in-person and synchronous online courses):

Students are expected to attend all class meetings. If unusual or emergency circumstances prevent class attendance, the student should notify the professor in advance if possible. Multiple absences from class will result in lower grades. The student is responsible for the material presented in classes missed (from EMU Graduate Catalog). Students should be aware of the importance of regular class attendance, particularly in the case of CJP classes that only meet once a week or over several weekends. Being absent for more than one class leads to a student missing a large portion of the class content. In addition to consistent class attendance, students should make every effort to arrive to class on time out of respect for the learning process, fellow students, and faculty.

I hope we can welcome differences and demonstrate a willingness to analyze issues from frameworks that may or may not feel comfortable. I have opinions, which I may express from time to time. Please be sensitive in your class participation by not unfairly dominating discussions. Be aware of others' right to speak and welcome questions from your classmates. My goal is to create a brave space in which everyone learns to participate in scholarly dialogue that values listening, thinking, feeling, study, and professionalism. - 1. Our primary commitment is to learn from each other. We will listen to each other and not talk at each other. We welcome differences amongst us in backgrounds, skills, interests, and values. We realize that it is these very differences that will increase our awareness and understanding through this process.
- 2. We will trust that people are always doing the best they can.
- 3. Challenge the idea and not the person. We debate ideas, not the individual sharing this idea or practice.
- 4. Each of us will strive to speak our discomfort. When something is bothering you, please practice sharing this with the group. Often our emotional reactions offer valuable learning opportunities.
- 5. Step Up, Step Back. Be mindful of taking up much more space than others. On the same note, empower yourself to speak up when others are dominating the conversation.
- 6. Stay engaged. When overwhelmed or stressed, it can be tempting to slip away from the class or group while meeting. Let us honor one another with focused connection. When we catch ourselves disengaging, let us gently refocus on the tasks at hand.

#### **Course Extensions and Outstanding Grades:**

For fall and spring semesters, all coursework is due by the end of the semester. If a student will not be able to complete a course on time, the student must submit a request one week before the end of the semester for an extension (up to 6 months), by emailing the instructor, academic advisor and the Academic Program Coordinator. If the request is granted the student will receive an "I (incomplete) for the course which will later be replaced by a final grade when the work has been turned in on the agreed upon date. If the request for an extension is denied, the student will receive a grade for the work that has been completed up until the time the course was expected to have been completed. If no work has been submitted, the final grade will be an F (or W under unusual circumstances and with permission of the Program Director). Extensions will be given only for legitimate and unusual situations. Extensions are contracted by the student with the program for up to a maximum of 6 months after the deadline for the course work. *PLEASE NOTE: Grades for coursework submitted late may be reduced at the instructor's discretion and in line with their course policy on turning in coursework after the due date. If the extension deadline is not met, the instructor will submit the final grade based on what has been received to date.* 

# Inclusive, Community-Creating Language Policy:

Bias reporting is a resource for anyone who needs to communicate an incident or explore a better understanding around issues of discrimination and learning how to effectively respond. All members of the university community are encouraged to report incidents of bias.

#### Title IX:

The following policy applies to any incidents that occur (on or off campus or online) while you are a <u>student registered at EMU</u>. It does not apply if you are talking about incidents that happened prior your enrollment at EMU. It is important for you to know that all faculty and staff members are required to report known or alleged incidents of sexual violence (including sexual assault, domestic/relationship violence, stalking). That means that faculty and staff members cannot keep information about sexual violence confidential if you share that information with them. For example, if you inform a faculty or staff member of an issue of sexual harassment, sexual assault, or discrimination they will keep the information as private as they can, but is required to bring it to the attention of the institution's Title IX Coordinator. You can also report incidents or complaints through the <u>online portal</u>. You may report, confidentially, incidents of sexual violence if you speak to Counseling Services counselors, Campus Ministries' pastors, or Health Services personnel providing clinical care. These individuals, as well as the Title IX Coordinator, can provide you with information on both internal & external support resources.

# **Criteria for Evaluating Arts-Based Peacebuilding Projects**

#### Background notes:

• Arts approaches can be used in several different stages of a project:

- 1. To gain or create knowledge. (For example, research "subjects" or participants might be engaged in an arts-based project as a way of soliciting information or encouraging insight.)
- To add complexity or nuance to created knowledge. (For example, an arts practice may serve as one method in a multi-method research project, creating an integrated, reflective methodology for the project. Alternatively, an arts practice could be used to analyze and/or interpret data collected by conventional methods.)
- 3. To test knowledge. (For example, researchers might verify their interpretation of findings from a more traditional research process by creating a play or exhibit and testing it for resonance with their subjects.)
- 4. To share findings. (For example, a play or exhibit might be created to (re)-present data collected or analyzed via conventional methods in order to impart the particular kinds of meaning the researcher considers important, and as a way to reach and engage a broader audience.)
- 5. As a form of intervention. (For example, a project might be designed to raise awareness of an issue or conflict, to promote dialogue on a contested issue, or to advocate for a cause.)

• Arts-based products often do not specify methodologies used. Thus it may be important for a project to be accompanied by a short paper discussing analysis, theory of change, audience, goals, and methods used.

• Patricia Leavy, *in "Method Meets Art: Arts-based Research Practice" (New York: Guilford Press)* 2009, argues that "[t]raditional conceptions of validity and reliability, which developed out of positivism, are inappropriate for evaluating artistic inquiry." (p. 15). She suggests that authenticity, trustworthiness, and validity can be assessed through attention to such elements as aesthetics, resonance, and vigor.
