COURSE DESCRIPTION: Is nonviolence effective for creating sustainable social change in the face of institutional, political, and violent resistance? How is the philosophy of nonviolence connected to nonviolent strategy and tactics? And can nonviolence still be relevant today? In this course, we look at the power of social movements to effect change using strategic nonviolence, including forms of protest and persuasion, noncooperation, and nonviolent intervention and direct action. We examine the theory, practice, history, and research behind nonviolence, and explore debates and criticisms about the efficacy of nonviolent social change. Our work will be grounded in a close study of the US Civil Rights Movement, as well as other social change movements from India to Serbia to South Africa, and recent movements from Occupy to Arab Spring to Environmental Justice. Through case studies and our own experiences, we will practice assessment, visioning, planning, and tactical skills, and also apply what we have learned to issues we care about. As we discuss whether nonviolence is “the way” or “one way” for us today, we will investigate the intersections of nonviolent social change with peacebuilding practices and social justice movements. Along with readings and classroom discussions and activities, we will engage with multimedia resources like film and music, and connect to real-life scenarios through individual and group research and presentations.

COURSE GOALS AND OBJECTIVES: This course will equip participants to:

1. Examine the theory, practice, history, and research of nonviolent social movements.
2. Explore nonviolence through case studies, discussions, and personal experiences.
3. Compare and contrast multiple theories of nonviolence, and their personal and social impacts.
4. Analyze criticisms and critical issues in nonviolent social change.
5. Synthesize and critically examine theoretical and applied research on nonviolent social change using clear, concise writing as well as oral communication.
6. Apply nonviolent social change to a variety of cases and contexts.

COURSE PHILOSOPHY: At CJP, we seek the creation of a dynamic learning community in which everyone is a teacher and a learner. Our personal and professional lives, social identities, cultural heritage and spiritual beliefs impact the way we, as instructors, understand the course content and how we present it. Likewise, we invite all course participants to bring the multiple dimensions of your experience and identity into the course. In order to encourage this stance, we ask that we all work to:

1. Respect others’ points of view (even when you think and believe differently),
2. Listen to gain insights, fresh ideas, and new perspectives,

3. Accept that we are here to learn with and from one another, and
4. Give each other the benefit of the doubt – each of us is on a different journey, with different life experiences, identities, and educational paths. Joining a new learning community (and for some, geographical community) causes uncertainty and necessary readjustment. Some of us deal with this by going with the flow, some of us deal with it by creating cocoons of certainty around ourselves. And most of us are somewhere in between. Let's give each other as much grace and flexibility as possible.

These principles are even more important as we engage with each other in a hybrid learning environment (blended online and in-person classes) where engagement must be intentional and scheduled. You will be asked to interact with each other and the instructors individually inside and outside of the synchronous sessions. We hope that you will share what you know, help us all to learn by listening with curiosity to others, help to hold us all accountable to our values, and find ways to share your constructive criticism, your concerns about process or content, and help us all to be at our best together.

REQUIRED ASSIGNMENTS:

These are brief descriptions of required graded assignments for the course. More details for each assignment can be found on the "Guidance Notes" that will be provided in class.

This course is offered for 2, 3, or no credits in the case of purely professional education or training. The different expectations of those taking the course for credit or auditing are indicated below.

Students are expected to complete all of the readings and written assignments and watch assigned videos listed in the Course Schedule (and posted on Moodle). Due dates in the Schedule are a suggestion for realistic course completion and meaningful learning. Contact me in advance of due dates if you need more time or flexibility.

Course Participation: 15% [expected of all participants]

Students are expected to attend each class session and be ready to participate in exercises and discussions:

- Read assigned texts and articles and watch assigned films and videos in advance each week and be prepared to engage in related activities
- Attend every scheduled class session and participate actively
- Complete ungraded assignments such as small group work, worksheets, and more
- Participate in pair or group meetings with classmates outside of synchronous class hours to discuss readings, practice exercises, get feedback, or complete other joint assignments
- Respond in a timely manner to communication from the instructor and fellow students

Group Presentation on Video: 5% [expected of all participants]

Groups of students will summarize a video and facilitate a class conversation from the series *Eyes on the Prize*. Presentations will be graded based on the following criteria: Preparation, Clarity of Presentation, Participation of each member, Engagement with Content, Class Discussion. Full description and instructions will be available in Guidance Notes on the Moodle site.

Group Presentation on Case Study: 5% [expected of all participants]

Groups of students will summarize and analyze a case study from *A Force More Powerful* or *Why Civil Resistance Works* and facilitate a class conversation. Presentations will be graded based on the following criteria: Preparation, Clarity of Presentation, Participation of each member, Engagement with Content, Class Discussion. Full description and instructions will be available in Guidance Notes on the Moodle site.

Individual Presentation on course reading: 10% [expected of all participants]

Individual students will summarize a reading and facilitate a class conversation. Presentations will be graded based on the following criteria: Preparation, Clarity of Presentation, Engagement with Content, Class Discussion. Full description and instructions will be available in Guidance Notes on the Moodle site.

Midterm Case Study Part 1: 30% [expected of all participants receiving 3 credits]

Choose a current social system, cultural group, or institution facing conflict and injustice, and develop a Case Study and analysis of how nonviolent philosophy and strategy can be implemented to achieve transformation towards more justice and peace. Connect and compare to course readings and resources, and contribute additional background research as needed. Full description and instructions will be available in Guidance Notes on the Moodle site.

Final Case Study Part 2: 30% [expected of all participants receiving credits]

Continue building and developing your Case Study from the Midterm using resources from the second half of the semester. Deepen your exploration of a current social system, cultural group, or institution facing conflict and injustice, and further develop your analysis of how nonviolent philosophy and strategy can be implemented to achieve transformation towards more justice and peace. Connect and compare to course readings and resources, and contribute additional background research as needed. Full description and instructions will be available in Guidance Notes on the Moodle site.

Final Presentation: 5% [expected of all participants receiving credits]

Individual presentation of your Final Case Study. Present your work to the class in a way that brings the content to life. In addition to talking, consider using guided activities and audiovisual materials such as a slideshow or video. Plan for a 10-15 minute presentation and a 5 minute time for Q&A and discussion for a total of 15-20 minutes. Full description and instructions will be available in Guidance Notes on the Moodle site.

Writing Guidelines:

Writing will be a factor in evaluation: EMU has adopted a set of [writing guidelines](#) for graduate programs that include six sets of criteria: content, structure, rhetoric & style, information literacy, source integrity, and conventions (see page 3). It is expected that graduates will be able to write at least a “good” level with 60% writing at an “excellent” level. For the course papers, please follow the APA style described in CJP’s *GUIDELINES for GRADUATE PAPERS* (see CJP Student Resources Moodle page or request a copy from the Academic Program Coordinator), unless directed otherwise by the instructor. Criteria for Evaluating Arts-Based Peacebuilding Projects can be found at the end of this document.

Academic Accountability & Integrity:

EMU faculty and staff care about the integrity of their own work and the work of their students. They create assignments that promote interpretative thinking and work intentionally with students during the learning process. Honesty, trust, fairness, respect, and responsibility are characteristics of a community that is active in loving mercy and doing justice. EMU defines plagiarism as occurring when a person presents as one’s own someone else’s language, ideas, or other original (not common-knowledge) material without acknowledging its source (Adapted from the Council of Writing Program Administrators). Moodle:

[Moodle](#) is the online learning platform that EMU has chosen to provide to faculty, administrators and students. Students will have access to course information within Moodle for any class they are registered for in a given term. The amount of time a student has access to information before and after the class is somewhat dependent on the access given to students by the individual faculty member. However, please note that courses are not in Moodle permanently – after two years the class will no longer be accessible. Please be sure to download resources from Moodle that you wish to have ongoing access to.

Technology Requirements and Communication/Zoom Best Practices:

Communication will largely be accomplished via the Moodle platform utilized by EMU and your EMU email. Check both frequently during the semester. Zoom will be used for synchronous online course sessions. Please review these [best practices](#) for online classes!

Institutional Review Board (IRB):

All research conducted by or on EMU faculty, staff or students must be reviewed by the [Institutional Review Board](#) to assure participant safety.

Grading Scale & Feedback:

In most courses grades will be based on an accumulation of numerical points that will be converted to a letter grade at the end of the course (several CJP courses are graded pass/fail). Assignments will receive a score expressed as a fraction, with the points received over the total points possible (e.g. 18/20). The following is the basic scale used for evaluation. *Points may be subtracted for missed deadlines.*

Graduate students are expected to earn A's & B's. A GPA of 3.0 for MA students and 2.75 for GC students is the minimum requirement for graduation.

Regarding feedback on papers/projects: Students can expect to receive papers/assignments back in a class with faculty feedback before the next paper/assignment is due. This commitment from faculty assumes that the student has turned the paper in on the agreed upon due date.

Library

The [Hartzler Library](#) offers research support (via e-mail, chat, phone, or SSC campus) and the library home page offers subject guides to help start your research. The library can help you acquire resources not held by EMU through the Interlibrary Loan (ILL) system. The link to ILL is on the left side of the library homepage.

Office of Academic Access:

If you have a physical, psychological, medical or learning disability that may impact your work in this course, it is your responsibility to contact the [Office of Academic Access](#). They will work with you to establish eligibility and to coordinate reasonable accommodations. All information and documentation is treated confidentially.

Class Attendance (for in-person and synchronous online courses):

Students are expected to attend all class meetings. If unusual or emergency circumstances prevent class attendance, the student should notify the professor in advance if possible. Multiple absences from class will result in lower grades. The student is responsible for the material presented in classes missed. Students should be aware of the importance of regular class attendance, particularly in the case of CJP classes that only meet once a week or over several weekends. Being absent for more than one class leads to a student missing a large portion of the class content. In addition to consistent class attendance, students should make every effort to arrive to class on time out of respect for the learning process, fellow students and faculty.

Religious Holidays

EMU respects the diversity of religious holidays and wishes to provide reasonable accommodations for students who may be unable to fully participate in class, lab, exams, or other assignments due to observation of a significant religious holiday. Students should provide adequate notice (a week in advance) to the faculty of such requests.

Classroom Culture & Related Policies

EMU's [Life Together](#) statement describes the sort of learning community that we aspire to be. Learning thrives where there is free and open exchange of ideas, thoughts, emotions, and convictions. Open discourse requires trust and safety. While I anticipate that you may find that some aspects of the class challenge your views and theoretical frameworks, I invite you to respectfully express either agreement or disagreement without fear of consequences. If you feel that I am violating this commitment, please make an appointment to meet outside of class so that we can discuss the issue.

I hope we can welcome differences and demonstrate a willingness to analyze issues from frameworks that may or may not feel comfortable. I have opinions, which I may express from time to time. Please be sensitive in your class participation by not unfairly dominating discussions. Be aware of others' right to speak and welcome questions from your classmates. My goal is to create a brave space in which everyone learns to participate in scholarly dialogue that values listening, thinking, feeling, study, and professionalism. 1. Our primary commitment is to learn from each other. We will listen to each other and not talk at each other. We welcome differences amongst us in backgrounds, skills, interests, and values. We realize that it is these very differences that will increase our awareness and understanding through this process.
2. We will trust that people are always doing the best they can.
3. Challenge the idea and not the person. We debate ideas, not the individual sharing this idea or practice.
4. Each of us will strive to speak our discomfort. When something is bothering you, please practice sharing this with the group. Often our emotional reactions offer valuable learning opportunities.
5. Step Up, Step Back. Be mindful of taking up much more space than others. On the same note, empower yourself to speak up when others are dominating the conversation.
6. Stay engaged. When overwhelmed or stressed, it can be tempting to slip away from the class or group while meeting. Let us honor one another with focused connection. When we catch ourselves disengaging, let us gently refocus on the tasks at hand.

Course Extensions and Outstanding Grades:

For fall and spring semesters, all coursework is due by the end of the semester. **If a student will not be able to complete a course on time, the student must submit a request one week before the end of the semester for an extension (up to 6 months), by emailing the instructor, academic advisor and the Academic Program Coordinator.** If the request is granted the student will receive an "I (incomplete) for the course which will later be replaced by a final grade when the work has been turned in on the agreed upon date. If the request for an extension is denied, the student will receive a grade for the work that has been completed up until the time the course was expected to have been completed. If no work has been submitted, the final grade will be an F (or W under unusual circumstances and with permission of the Program Director). Extensions will be given only for legitimate and unusual situations. Extensions are contracted by the student with the program for up to a maximum of 6 months after the deadline for the course work. *PLEASE NOTE: Grades for coursework submitted late may be reduced at the instructor's discretion and in line with their course policy on turning in coursework after the due date. If the extension deadline is not met, the instructor will submit the final grade based on what has been received to date.*

Criteria for Evaluating Arts-Based Peacebuilding Projects

Background notes:

- Arts approaches can be used in several different stages of a project:
 1. To gain or create knowledge. (For example, research "subjects" or participants might be engaged in an arts-based project as a way of soliciting information or encouraging insight.)
 2. To add complexity or nuance to created knowledge. (For example, an arts practice may serve as one method in a multi-method research project, creating an integrated, reflective methodology for the project. Alternatively, an arts practice could be used to analyze and/or interpret data collected by conventional methods.)
 3. To test knowledge. (For example, researchers might verify their interpretation of findings from a more traditional research process by creating a play or exhibit and testing it for resonance with their subjects.)
 4. To share findings. (For example, a play or exhibit might be created to (re)-present data collected or analyzed via conventional methods in order to impart the particular kinds of meaning the researcher considers important, and as a way to reach and engage a broader audience.)
 5. As a form of intervention. (For example, a project might be designed to raise awareness of an issue or conflict, to promote dialogue on a contested issue, or to advocate for a cause.)
- Arts-based products often do not specify methodologies used. Thus it may be important for a project to be accompanied by a short paper discussing analysis, theory of change, audience, goals, and methods used.
- Patricia Leavy, in *"Method Meets Art: Arts-based Research Practice"* (New York: Guilford Press) 2009, argues that "[t]raditional conceptions of validity and reliability, which developed out of positivism, are inappropriate for evaluating artistic inquiry." (p. 15). She suggests that authenticity, trustworthiness, and validity can be assessed through attention to such elements as aesthetics, resonance, and vigor.
