# **COURSE DESCRIPTION:**

Foundations 1 and 2 give a comprehensive overview of justice and peacebuilding practice and its multidisciplinary, multi-level aspects. Foundations 1 centered on personal, interpersonal, small group and organizational transformation analysis, theory and practice. Foundations 2 focuses on communal, societal and global processes of transformation, with particular attention to the relationship between power and the production of justice and peacebuilding theories and practices. Throughout the two courses, you will be required to understand and integrate ethical application of theory, technical utilization of analysis tools, and systematic processes of planning and implementation for practice interventions across a myriad of sectors in society.

In this course, faculty continue to coach students as they further develop their knowledge and skills for dealing with conflict and situations of injustice and building sustainable peace, with increased sensitivity to race and gender as well as history, and political economy. Students work individually and in teams to learn new theories and concepts and to apply these ideas and skills to cases that progress in complexity from the community to the national and global levels (and back again). Throughout the course, we also examine the intersections and overlaps among the local and the global.

Students continue to develop their self-awareness as well as their capacity for professional judgment and reflective practice. Students become familiar with theories and frameworks that help explain the causes and dynamics of larger-scale conflicts, injustice and structural violence. They explore the roles of social-movement organizations, practitioner groups and policy engagement for dealing with such situations. Students prepare for future employment by completing assignments that develop professional skills, including but not limited to: communicating complex ideas clearly and succinctly, working in teams on complex projects, researching strategies and moving from analyzing a situation of injustice or conflict to designing and preparing strategies to impact that situation.

# COURSE GOALS AND OBJECTIVES:

Our course goals and objectives emerge out of three general areas focusing the development of a foundation in justice and peacebuilding theory and practice: overview of the field; analysis and practice; and formation and vocation.

# **Overview of the field: [CT, RJ, Development/Political Economy;** see the strategic peacebuilding wheel]

- 1. Continue to develop deeper familiarity with the fields of justice and peacebuilding:
  - a. Gain a comprehensive overview of justice and peacebuilding theories and frameworks (and their social, political, and economic trajectories).
  - b. Trace the "genealogy" of the field and its bodies of knowledge and practice.
  - c. Develop a working understanding of key theoretical schools of thought in the social sciences, in order to analyze the causes and consequences of complex and protracted conflict and structural violence (explanatory theories) and to develop strategies to mitigate or transform those situations (prescriptive theories).

## Analysis and practice: [interpersonal, communal, social, state, global]

- 2. Provide a comprehensive overview of justice and peacebuilding practice and its multi-disciplinary, multi-level aspects (Foundations II focuses on communal, societal and global change).
- 3. Understand and integrate ethical application of theory, technical utilization of analysis tools, and systematic process of planning and implementation across a myriad of sectors in society (e.g. case study with context, conflict analysis and intervention).
  - a. Critically assess analytical models ('lenses' or 'tools') and processes, identify the assumptions behind these models, and choose models that will enable all involved to reconsider typical narratives about the situation.
  - b. Conduct all stages of justice and peacebuilding assessment, design and planning processes.
  - c. Design and carry out basic planning, monitoring, evaluation and reporting (PMER).

# Formation and vocation: [intrapersonal and relational, values, ethics, faith, spirituality, care]

- 4. Develop self-awareness, capacity for professional judgment and reflective practice (prepare for future employment by completing assignments that develop personal and professional skills).
  - a. Strengthen capacity for analytic empathy and sensitivity to competing understandings of 'reality' that exist in conflict as well as complexities within situations of violence & injustice.
  - b. Heighten awareness of one's personal values framework and an ability to think ethically about one's engagement in the world.
  - c. Increase skill for working collaboratively in teams, engaging in personal and group assessment of practice and maintaining disciplines for self-care and community care.
  - d. Deepen critical reflection and understanding of one's own personal and social identity, and the social identities of others while attending to culture, history, and power relations.
- 5. Increase skill in non-academic writing of complex ideas and practices for professional and public audiences

# **REQUIRED ASSIGNMENTS:**

Course evaluation will be based on students' demonstration of critically engaging, analyzing, and applying the course material. The final grade will be based on the following course requirements:

- Class participation and presentation: 15%
- Blog and online discussion: 15%
- Group project and class facilitation: 40% + 10%
- Reflective research essay: 20%

*Note:* Most course assignments are due on Mondays at 11:59 p.m. Eastern time. There are some exceptions. Assignments will be submitted via Moodle unless otherwise indicated. Assignments should be double-spaced, 12-point, Times Roman Numeral font, one-inch margins, and include a word count. All references should be properly cited using the reference style stipulated in the Guidance Notes, or a consistent reference style of your choice (e.g. APA, MLA, Chicago) when a specific style is not specified. Late assignments will result in a deduction of half a grade for each day late, unless an extension has been requested and approved in advance.

# **Class participation and presentation (15%)**

This semester, class will take place virtually through the use of Zoom, a video platform and VoiceThread, a multimedia platform that hosts slideshows where participants comment in various ways including through voice and video. Active participation in class discussions and exercises in both spaces will be an important part of this course. Students are expected to attend all synchronous class sessions and take an active and constructive role in class discussions and presentations, in both Zoom and VoiceThread. Please arrive to Zoom class sessions on time and remain until the end of each session. We also ask that all students be present from a quiet space with a fully functional microphone and video, whenever possible. While we cannot replicate the conditions of a face-to-face class session, we would like to create the conditions that allow us to fully engage personally and professionally online.

# **Class participation and presentation includes:**

- A. Active Reading & Written Reflection: Course readings including written materials, podcasts and videos will expose you to conceptual and analytical frameworks, issues, theories, and approaches. Completing the readings and taking careful notes on key concepts, theories, and ideas, will be crucial to effective participation in the class and for achieving the learning objectives. All participants are asked to share with the class some of their key 'take home points,' critical questions, and potential implications and applications that emerged for them from the readings <u>eight times</u> over the course of the semester. You can choose which weeks to share your written reflections, which will also be a resource for others. As you interact with the content, pay attention to your thoughts and reactions as well as situations and stories that come to mind.
- B. **VoiceThread Reading Responses:** Participants are required to view weekly slideshows provided via VoiceThread and respond to the readings and prompts through video, voice, and text comments on the VoiceThread platform. The slideshows will be posted on VoiceThread by Tuesdays at 5 pm Eastern time. Your responses are due on Thursdays at 9 am Eastern time.
- C. Learning with Care: We want to ensure a healthy space for conversation and learning by promoting practices that include active listening, asking questions respectfully, openness to multiple voices, finding your own perspective while respecting others' perspectives, being aware of your impact on others, and being sensitive to others' needs and concerns; in other words, please participate in ways that invite the participation of your colleagues. As these are critical skills in justice and peacebuilding, they are also key factors in your evaluation. If you are taking notes on your device, please refrain from engaging in other activities (e.g. social media). This course will often explore topics and experiences that have caused harm and/or trauma responses in people's lives and communities. With this in mind, we will be utilizing a *Trauma-Informed Classroom Care Model* (see appendix). If you find yourself struggling with your mental or physical health this semester, please feel free to approach us. We try to be flexible and accommodating. # Blog and online discussion in the class 'blogosphere' (15%)

This assignment is aimed at helping you (a) to integrate and synthesize the theories explored (b) to reflect on your existing perspectives, lived experience, and professional practice and (c) to become familiar with the art and technique of communicating complex ideas simply and clearly to non-specialist audiences, participating constructively in the 'public' debate around those ideas. Write a short analytical essay (a 'blog') of 800-1,000 words that **advances a specific idea original to you** in connection to the issues, theories, concepts and practices explored in Part 1 of the course (weeks 1-3). Your blog must be posted no later than <u>Monday</u>, February 22 at 11:59 p.m. Eastern time. You will then have 5 days to participate in the class 'blogosphere', commenting on classmates' blogs and online discussion. The class blogosphere 'closes' on <u>Saturday</u>, February 27 at 11:59 p.m. Eastern time There will be up to 100 points for the contents and form of your blog post and up to 50 points awarded for the content and scope of your participation in the discussions in our blogosphere.

# Group project: Transnational Explorations of Justice & Peacebuilding

# Part I: Group study and project development (40%)

In small groups of 3 - 4 members, you will identify an issue (e.g. police violence, forced displacement) that manifests as a site of violence locally and globally and study that issue through five movements or phases of exploration: narration, manifestation, inspiration, imagination, and application.

1. *Narration*: tell a story about the issue, narrating examples of what this violence looks like and is experienced in three different national contexts.

2. *Manifestation:* perform an analysis explaining how this issue presents in these three different contexts using a variety of critical tools of analysis.

Inspiration: explore and curate different responses that address these forms of violence based in various modalities of justice and peacebuilding (e.g. community organizing, restorative justice, etc.) 4.
 Imagination: tell a new story where the presenting issue no longer exists or is drastically different.
 Application: develop a response/ engagement/ intervention to one of the initial narratives of violence that emerges from imagination and vision and moves toward the new story.

The final product may be in the form of a written paper, a series of blog posts, or some other multimedia format (e.g. a web site), a video with narration, a series of podcasts, or another creative format. Request and obtain permission in writing to use a creative format before commencing work. The final project is due <u>Friday</u>, <u>April 16 at 11:59 pm Eastern time</u> (Note that the CJP Comprehensive Exam is open from Friday, April 16 - Sunday April, 25. Be sure to plan your time accordingly.)

# Part II: Resource sharing & class facilitation (10%)

In addition to the final product, each group will be assigned to present their work and facilitate one of our course week's synchronous meetings, as well as developing the VoiceThread guiding asynchronous engagement. Leading the class discussion, groups will provide input, develop questions for discussion, and curate and share resource materials for the class to learn about your issue. Instructors will share a survey with students the first week of class to assist in the small group formation. Groups will present during one of the following weeks of the class on <u>Thursdays, March 25, April 1, 8, or 15</u> and post their VoiceThread slideshow before class by the Tuesday of this week). *Instructors will check in throughout the assignment and accompany groups as they work, but this assignment is an opportunity for students to immerse in this issue and will require self-direction.* 

# Reflective research essay (20%)

This assignment integrates two complementary approaches to knowledge production: reflective writing (as in a reflective essay) and academic and professional research (as in a traditional research paper). For this paper, you will need to choose a specific thematic challenge and key question that is central to your vocational interests in the field. You will map out this question, analyze how the literature, as well as your lived experiences, suggests possible ways of understanding it, and identify relevant processes and methods for contributing to justice and peacebuilding that emerge from your reflection and analysis.

As a reflective research essay, we ask that you engage in both research and reflection on practice:

- 1) Draw on the readings assigned for this course and other academic and professional sources.
- 2) Deeply reflect on your own perspectives and past work, mining the lessons, theories, strategies and ideas you have also learned through lived experience and on-the-ground practice.

You are strongly encouraged to go beyond the normative canon of literature on peacebuilding and justice to develop and utilize an archive of resources from organizers, activists, peacebuilders, justice

© 2021 Johonna Turner and Timothy Seidel *PAX-634 Spring 2021*  leaders, cultural workers and theorists from a particular region of the world, social identity, or context – as is appropriate to your project. This project should be the equivalent of a paper in the 2,000 - 2,500 word range (8 - 10 pages double-spaced). You will need to choose a specific 'form' for this paper, such as a scholarly article, professional discussion paper, series of blogs, or public talk or presentation (e.g. the script of a talk to a specific audience; a powerpoint with the talking points written out in the 'notes' section). This can also be presented in the form of a multimedia project (e.g. a web site), a video with an explanatory memo, a series of podcasts, or another creative format. *Request and obtain permission in writing to use a nontraditional format before first drafts are due*.

- 1. *Project identification.* A one-paragraph project proposal (including your key question, topic and format) is due by Monday, February 8 at 11:59 p.m. Eastern time.
- 2. Abstract and bibliography. A one-paragraph summary description of your project including its broad goals, methods, and a short list of relevant references is due by Monday, March 1 at 11:59 p.m. Eastern time.
- 3. *Final project and presentation.* Final projects must be submitted to Moodle by Monday, April 26 at 11:59 p.m. Eastern time. Presentation of final projects will take place via VoiceThread, and must be posted by Tuesday, April 27 at 11:59 pm Eastern time.

These are brief descriptions of required graded assignments for the course. More details for each assignment can be found on the "Guidance Notes" that will be provided in Moodle at the start of the semester.

#### **Critical Pedagogy:**

"Education can only be liberatory when all of us claims knowledge as a field in which we all labor. - bell hooks, *Teaching To Transgress.* 

Our pedagogy (approach to teaching) is informed by critical pedagogues including bell hooks, Paulo Freire, and Augusto Boal. Thus, we seek to move away from the dominant 'banking' method of teaching (Freire) to what bell hooks has termed "education as the practice of freedom." We commit ourselves to the practices of self-reflexivity, critical thinking, listening, re-directing attention to your own voices and those of others and hope that you will also commit to the struggle we embark upon together.

#### Trauma-Informed Classroom Care:

This course will be exploring ideas and experiences that have caused harms and traumagenic responses in people's lives and communities. Some course content includes accounts and descriptions of violence and oppression including sexual violence and abuse, racial violence, colonialism, and other interpersonal and systemic harms. With this in mind, we will be utilizing a Trauma-Informed Classroom Care Model.<sup>1</sup> Elements of this model include:

- Trauma Exposure Course objectives may expose students to elements of trauma and trigger traumatic stress. There will, at times, be content forecasting notes placed on particular texts.
- Reactions to Trauma How a student responds to traumagenic information or events varies from student to student and depends on personal history. This course design seeks to reflect three phases of trauma recovery: Safety, Remembrance and Mourning, and Reconnection (integration).
- Student Disclosure of Trauma Students have the opportunity to disclose personal experiences of trauma in a variety of ways. These might include: individual meeting with the instructor, during small group discussions, or in writing through personal reflection, email, writing/class assignments.
- Flexibility Students with higher levels of reactivity to course content will be met with a higher level of flexibility.
- Course Progression The instructor will inform students of the topics and progression of the course.
- Assessment Assessments are used to not only measure progress toward stated objectives and student learning but also monitor student response. This will be done in a variety of ways.

#### SUPPLEMENTAL INFORMATION FOR COURSE SYLLABI:

#### Writing Guidelines:

*Writing* will be a factor in evaluation: EMU has adopted a set of writing guidelines for graduate programs that include six sets of criteria: content, structure, rhetoric & style, information literacy, source integrity, and conventions (see page 3). It is expected that graduates will be able to write at least a "good" level with 60% writing at an "excellent" level. For the course papers, please follow the APA style described in CJP's *GUIDELINES for GRADUATE PAPERS* (see CJP Student Resources Moodle page or request a copy from the Academic Program Coordinator), unless directed otherwise by the instructor.

#### Academic Integrity Policy (AIP):

EMU faculty and staff care about the integrity of their own work and the work of their students. They create assignments that promote interpretative thinking and work intentionally with students during the learning process. Honesty, trust, fairness, respect, and responsibility are characteristics of a community that is active in loving mercy and doing justice. EMU defines plagiarism as occurring when a person presents as one's own someone else's language, ideas, or other original (not common-knowledge) material without acknowledging its source (Adapted from the Council of Writing Program Administrators). This course will apply <u>EMU's AIP</u> to any events of academic dishonesty. If you have doubts about what is appropriate, <u>Indiana University's Plagiarism Tutorials and Tests</u> may be a useful resource.

#### Turnitin:

Students are accountable for the integrity of the work they submit. Thus, you should be familiar with EMU's Academic Integrity Policy (see above) in order to meet the academic expectations concerning appropriate documentation of sources. In addition, EMU is using <u>Turnitin</u>, a learning tool and plagiarism prevention system. For CJP classes, you may be asked to submit your papers to Turnitin from Moodle.

#### Moodle:

<u>Moodle</u> is the online learning platform that EMU has chosen to provide to faculty, administrators and students. Students will have access to course information within Moodle for any class they are registered for in a given term. The amount of time a student has access to information before and after the class is somewhat dependent on the access given to students by the individual faculty member. However, please note that courses are not in Moodle permanently – after three years the class will no longer be accessible. <u>Please be sure to download resources from Moodle that you wish to have ongoing access to.</u>

#### Technology Requirements and Communication/Zoom Best Practices:

#### Institutional Review Board (IRB):

All research conducted by or on EMU faculty, staff or students must be reviewed by the <u>Institutional</u> <u>Review Board</u> to assure participant safety.

#### Grading Scale & Feedback:

In most courses *grades* will be based on an accumulation of numerical points that will be converted to a letter grade at the end of the course (several CJP courses are graded pass/fail). Assignments will receive a score expressed as a fraction, with the points received over the total points possible (e.g. 18/20). The following is the basic scale used for evaluation. *Points may be subtracted for missed deadlines*.

95-100 = A outstanding	90-94 = A- excellent	85-89 = B+ very good

Graduate students are expected to earn A's & B's. A GPA of 3.0 for MA students and 2.75 for GC students is the minimum requirement for graduation.

*Regarding feedback on papers/projects:* Students can expect to receive papers/assignments back in a class with faculty feedback before the next paper/assignment is due. This commitment from faculty assumes that the student has turned the paper in on the agreed upon due date.

#### Library

The <u>Hartzler Library</u> offers research support (via e-mail, chat, phone, or SSC campus) and the library home page offers subject guides to help start your research.

#### Office of Academic Access:

*If* you have a physical, psychological, medical or learning disability that may impact your work in this course, it is your responsibility to contact the <u>Office of Academic Access</u>. They will work with you to establish eligibility and to coordinate reasonable accommodations. All information and documentation is treated confidentially.

#### Class Attendance (for in-person and synchronous online courses):

Students are expected to attend all class meetings. If unusual or emergency circumstances prevent class attendance, the student should notify the professor in advance if possible. Multiple absences from class will result in lower grades. The student is responsible for the material presented in classes missed (from EMU Graduate Catalog). Students should be aware of the importance of regular class attendance, particularly in the case of CJP classes that only meet once a week or over several weekends. Being absent for more than one class leads to a student missing a large portion of the class content. In addition to consistent class attendance, students should make every effort to arrive to class on time out of respect for the learning process, fellow students and faculty.

#### **Course Extensions and Outstanding Grades:**

For fall and spring semesters, all coursework is due by the end of the semester. If a student will not be able to complete a course on time, the student must submit a request one week before the end of the semester for an extension (up to 6 months), by emailing the instructor, academic advisor and the Academic Program Coordinator. If the request is granted the student will receive an "I (incomplete) for the course which will later be replaced by a final grade when the work has been turned in on the agreed upon date. If the request for an extension is denied, the student will receive a grade for the work that has been completed up until the time the course was expected to have been completed. If no work has been submitted, the final grade will be an F (or W under unusual circumstances and with permission of the Program Director). Extensions will be given only for legitimate and unusual situations. Extensions are contracted by the student with the program for up to a maximum of 6 months after the deadline for the course work. *PLEASE NOTE: Grades for coursework submitted late may be reduced at the*

# Criteria for Evaluating Arts-Based Peacebuilding Projects

## Background notes:

• Arts approaches can be used in several different stages of a project:

- 1. To gain or create knowledge. (For example, research "subjects" or participants might be engaged in an arts-based project as a way of soliciting information or encouraging insight.)
- 2. To add complexity or nuance to created knowledge. (For example, an arts practice may serve as one method in a multi-method research project, creating an integrated, reflective methodology for the project. Alternatively, an arts practice could be used to analyze and/or interpret data collected by conventional methods.)
- 3. To test knowledge. (For example, researchers might verify their interpretation of findings from a more traditional research process by creating a play or exhibit and testing it for resonance with their subjects.)
- 4. To share findings. (For example, a play or exhibit might be created to (re)-present data collected or analyzed via conventional methods in order to impart the particular kinds of meaning the researcher considers important, and as a way to reach and engage a broader audience.)
- 5. As a form of intervention. (For example, a project might be designed to raise awareness of an issue or conflict, to promote dialogue on a contested issue, or to advocate for a cause.)

• Arts-based products often do not specify methodologies used. Thus it may be important for a project to be accompanied by a short paper discussing analysis, theory of change, audience, goals, and methods used.

• Patricia Leavy, *in "Method Meets Art: Arts-based Research Practice"* (New York: Guilford Press) 2009, argues that "[t]raditional conceptions of validity and reliability, which developed out of positivism, are inappropriate for evaluating artistic inquiry." (p. 15). She suggests that authenticity, trustworthiness, and validity can be assessed through attention to such elements as aesthetics, resonance, and vigor.
